However in recognition that services can at times be especially crowded, it is essential to consistently encourage and challenge all congregation members to attend any of the six weekly services offered across the parish. If any specific service(s) is/are oversubscribed, ticketing or limited numbers may need to be introduced for that specific service to ensure sufficient space for all those attending. When the temperature drops to levels which would be uncomfortable to keep all doors and windows open, it is advised that following each service, doors and windows are opened to allow the air to be sufficiently replaced. It is recommended that at all times no matter the temperature two windows are left open at all times to allow some degree of continual air replacement.	During the week it is recommended the doors are left open with the heating off to allow good airflow throughout the week for anyone attending for private prayer. All staff will be requested to wear a face covering to demonstrate good practice. All others attending will be recommended to also except for those seated in the south aisle of Ashington or Washington who should be wearing face coverings. Buncton does not have a south aisle reserved for this, and instead has increased airflow. During ministry times, make sufficient space at the front, by clearing chairs ahead of calling people forward. Ministry team should offer face coverings to those they are praying for, and continue to offer them throughout the ministry time, not lowering them to be heard more clearly. Whoever is leading the service, should make clear to those responding that the ministry team will offer face coverings. If an individual is hard of hearing standing side by side facing rather than face to face, or facilitating the ministry time outdoors would be a safer approach. Professional cleaning with no known transmission	STAFF MEMBE R	If the church building has been closed for 48 hours between periods of being open then there is no need for extra cleaning to remove the virus from surfaces. If 48-hour closure is not possible then advise cleaners to conduct an even deeper comprehensive clean. Metal, wood, stone, glass, ceramic, and modern painted surfaces, should be cleaned with a dilute solution of non-ionic conservation-grade detergent or sensitive washing up liquid and distilled water, rinsed with distilled water and dried immediately with white paper towel. Cleaning materials should be disposed of appropriately, wrapped up and binned daily	Ensure an adequate supply of soap and disposable hand towels, and a bin for towels, are available.
